Useful information for Clinically Extremely Vulnerable workers and their employers

On 22 February, the Government published a roadmap out of the national restrictions for the whole population, which explains how restrictions will be eased over time. From 1 April 2021, clinically extremely vulnerable (CEV) individuals are no longer advised to shield.

Everyone is advised to continue to work from home where possible, but CEV individuals who cannot work from home are no longer advised not to attend their workplace. Employers are required to take steps to reduce the risk of exposure to COVID-19 in the workplace and should be able to explain to staff the measures they have put in place to keep them safe at work.
